



## APPLICATION FOR CROSS-REGISTRATION

Please submit for each horse to be registered:

1. A completed **Application for Cross-Registration form** (the second page of this document).
2. The **original registration papers** from the first registry to register the horse. Original documents will be photocopied and returned.
3. A photocopy of the marking chart used in the original registration if the marking chart is not contained in the original registration document AND/OR if the horse is microchipped, a Microchip Reading Certificate.
4. A photocopy of the page of **any other registration documents** showing the horse's name and registration number in that registry including the horse's Equine Canada passport if it has one.
5. A blood typing or DNA testing **certificate confirming the relationship to both parents** must be received by the Society from the testing lab before a registration certificate will be issued. If the horse's parentage has not been verified by DNA testing or blood typing or you are not sure, please contact the Registration Officer for assistance.
5. Unless the horse is microchipped, a set of **four photographs** showing the horse's markings clearly: left side, right side, face (close-up) and back end. These photographs will be compared to the marking chart in or with the original registration document to confirm the horse's identity so please ensure that all white markings shown on the marking chart can be seen clearly in the photographs. Digital photographs sent by email to [registration@idhs.ca](mailto:registration@idhs.ca) are preferred but not essential.
6. For horses being submitted for cross-recognition as Registered Irish Draught, Class 1 Irish Draught, Class 2 Irish Draught, Class 3 Irish Draught, Appendix Irish Draught, Grade up Register Mare or Approved Irish Draught Sport Horse, documentary proof of inspection results will be required; please make the appropriate arrangements for the documentation to be released to the IDHSC from the society that performed the inspection.
7. All fees are due and payable in Canadian funds. If you pay by PayPal, please enclose the receipt from PayPal or email your receipt to the registration officer (email address below).

**Note: Cross-registration of horses inspected and approved for breeding by other Canadian breed associations does not confer approval by the IDHS (Canada).**

Payment may be made by cheque or money order made out to the *Irish Draught Horse Society of Canada*, by Interac or PayPal via our webstore on [idhs.ca](http://idhs.ca) or by credit card via the Society's webstore. If membership is being sent with the registration documents, the fee may be included all in one payment, however a membership application will need to be filled out and sent by either mail or email.

A Registration Certificate will be issued to cross-registered horses. If you want a full Canadian passport, you must also submit an Identification Certificate (marking diagram) completed and signed by a veterinarian unless the submitted Identification Certificate is acceptable and photographs as described above.
